Eligibility for applicants

Applicants must fulfil the educational qualification, experience and age limit and other cr for the post, as on the last date of receipt of the applications, failing which the application shall be summ rejected and no correspondence will be entertained in this regard. Candidates are, therefore, advised to sa themselves before applying for the post that they possess the requisite essential qualification and experis The prescribed essential qualifications are the bare minimum and mere possession of the same does not entitle candidates to be called for the interview/selection.

AGE RELAXATION FOR GOVERNMENT SERVANTS:

The upper age limit is relexable for Government servants and orthopedically handicap (OH) upto 10 years.

The age relaxation will be admissible to such of the Government servants as are working posts which are in the same line or allied cadres and where a relationship could be established that the serval already rendered in a particular post will be useful for the efficient discharge of the duties of the post recruitment to which has been advertised. The above concession will be admissible only where an employ has rendered not less than three years continuous service under Government.

SCHEME OF SELECTION

Selection of the aforesaid post will be on the basis of written and practical test which wil conducted by a duly constituted Selection Committee. - 2) Candidates should note that only the date of birth as recorded in the Matriculation/Secondary Examination certificate of an equivalent examination will be accepted and no subsequent request for its change will be considered or granted.
- 3) Candidates claiming to OBC status may note that certificate on creamy layer status in the prescribed format (Annexure-II) should have been obtained within 3. Years before the closing date.
- 4) Candidate claiming to belong to one of the Scheduled Caste or Scheduled Tribe should submit in support of his/her claim an attested/certificate copy in the prescribed formant (Annexure-III) from the District Officer or the Sub-Divisional Officer or any other officer as listed in the format.
