3. The quotation received in time will be opened at the Chamber of the Director (EZ), WSC, Guwahati. The bidder or their representative (Not more than one) may remain present at the time of opening of quotation.

4. The auction will be governed by the following conditions:-

- i. The bidder is required to pay Earnest Money Deposit (EMD) of **₹3,000/- (Rupees Three thousand)** only payable by means of Demand Draft drawn in favour of Director, Weavers Service Centre, Guwahati.

- ii. Quotation received without demand draft towards EMD will not be considered.
- iii. The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of the Director (EZ), WSC, Guwahati
