Applications are invited against the following posts which are to be filled on contractual basis in the various SCDP in the Maharashtra State.

**1. Textile Designer**

- The applicant should be passed out from NIFT/NID or from any institute of repute with an experience of at least 02 years working as Textile Designer.
- Preferably with experience of working in Handlooms and should have track record for promotion and development of Textile including Handlooms.
- The appointment of Textile Designer is for a maximum period of three years and fixed remuneration @ Rs. 30,000/- per month.

**2. Cluster Development Executive (CDE)**
